AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Commissioners in a letter dated December 19, 2018, related to procurement using the “piggybacking” method. We appreciate the District’s commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Mukilteo Water and Wastewater District from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District’s uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts payable – general disbursements, credit cards, and petty cash transactions
- Procurement – public works, purchases, and change orders
- Compliance with state grants
- Contract compliance – third-party cash receipting
- Bond requirements for treasurer

INFORMATION ABOUT THE DISTRICT

The Mukilteo Water and Wastewater District provides service to approximately 24,100 residents in the Mukilteo and South Everett areas. A three-member Board of Commissioners is elected by the ratepayers to serve staggered six-year terms.

The Board sets the general policies for the operation of the District and appoints a General Manager to oversee the District's daily operations. For fiscal years 2016 and 2017, the District reported operating expenses of approximately \$9.3 million and \$9.1 million respectively.
